*If you prefer to send in a non-refundable deposit of \$250 by September 30th 2016, you may postpone your full payment until **December 18th**, but your payment in December must be in certified funds only. If full payment is not received by **December 18th** your reservation will be canceled and your non-refundable deposit will be forfeited.*

All concession spaces are 10 feet deep, regardless of width. Each concession space is a minimum width of 10 feet and can be increased in width in 10 foot wide increments at additional cost. For example:

INITIAL SPACE (10' deep by 10' wide (minimum))	\$ 560
EACH ADDITIONAL 10FT INCREMENT	\$ 490

Your wares may not overflow/extend outside of your assigned space into the aisle. If you will be using a canopy it must fit completely within your assigned space. Specifically, it may not extend out into the aisle. Also, you will be adjacent to other vendors, so you must respect their assigned space. When using a canopy, a working smoke detector is required, by order of the Fire Marshall, to be mounted above your wares and near the top (inside) of your canopy.
