The last couple of years have been a challenge for our sport and The Rose City Classic Series of Dog Shows is pleased to invite you to offer your merchandise at our new summer 4-day event. It is a new venue, outdoors and lots of room. The all-breed shows begin on Thursday, July 29, 2021, and continue through, Sunday, August 1, 2021. Setup day is Tuesday, July 27, 2021 (time for set up TBA) – The show will begin Specialty Day, Wed July 28<sup>th</sup> followed by 4 All Breed days, running Thursday 7/29/2021 thru Sunday 8/1/2021

**Payment must be received by midnight July 15, 2021.** We would appreciate a confirmation e-mail ASAP to reserve a space – this is a new venue and the sooner we know we can get started on vendor booth placement.

When your payment is received, please note that you will receive a confirmation e-mail of receipt.

Thank you all for being so patient – After the unfortunate COVID-cancellation of our January 2021 shows, Dog Fanciers and Tualatin have worked very hard to be able to put together a summer show for our exhibitors.

As you know the last couple of years has been a challenge for our sport!

We have 15 Specialties on Wed and 4 designated specialties during the 4 all-breed shows.

The show site is incredible. We have lots of room for social distancing and currently with the governor's approval for outdoor activities it should prove to be an enjoyable event. We will keep in mind that could change but positive thoughts are first and foremost.

We are excited to be offering vendor space.

This is outdoors so a canopy will be needed – and keep in mind when setting up – social distancing. If you have side curtains that will help with spacing of booths.

#### **Standard rules for vending at Rose City Classic**

1. Your set-up and wares may not overflow or extend outside of your assigned booth space into the aisle.
2. You will need a canopy it must fit completely within your assigned space, not extending into the aisle, or interfering with an adjacent booth.
3. Subletting of Space: No exhibitor shall assign, sublet, or apportion the whole or any part of the space allotted, without the knowledge and consent of management. Each firm represented in the show must sign the regular contract form for space.
4. Distribution of Advertising Matter: Distribution of circulars or advertising matter of any description, including souvenirs, will be restricted to the exhibitor's booth unless approved by DFOA.
5. Nestle Purina exclusive: No other competing pet food companies promoting and/or selling dry or wet dog food will be permitted to attend this event or in any other capacity (i.e. signage)
6. Bounced checks will be assessed a \$35 fee.
7. Insurance. Exhibitors wishing to insure their goods must do so at their own expense. The show assumes no responsibility for the safety of exhibitor's property, its offices, agents or employees from theft, damage by fire, accident, or other cause, but will use reasonable care to protect them against such loss.
8. If you do not have insurance, please contact Patti Strand for a company that has reasonable rates for events.
9. AKC Rule. This space is sold with the understanding that should the privileges of The AKC be withdrawn from the purchaser of this space prior to the carrying out of this contract, this contract is hereby automatically cancelled, and any money paid by purchasers for such space shall be refunded.
